



#### **CONDITIONS OF ENTRY**



WHITEGROVE TROPHY The award is given annually to the farmer in Staffordshire who, in the opinion of the Judge, has done most to encourage conservation on his/her farm alongside successful commercial activity. Consideration will be taken to include flora and fauna, but will also include landscape and historical interests.

WHO CAN ENTER Entries are invited from all farmers, farm managers and landowners in Staffordshire, whether tenants or owners. Past winners are excluded from re-entering the competition for 5 years.

HOW WILL I BE JUDGED? When you are satisfied with your entry, please send this application form to: Chris Seabridge & Associates Ltd, Friesland, Butterhill, Coppenhall, Stafford, ST18 9BX. After the closing date of the competition you will be contacted to arrange for the judge to be shown around your farm. The judge's visit will take a maximum of 2 hours, and will involve you showing the features and discussing the farm management that you feel is important to support your entry.

#### JUDGING SCHEDULE

Consider the standard of commercial farming including the commercial enterprise and its environmental impact.

Consider also:

- Resource Protection (soil, air & water)
- Farm Wildlife
- Business resilience

Evaluate the principles by which the farm is managed and the environmental benefits these have brought.

- How have the commercial and environmental needs been integrated?
- How have the habitats present been created or managed?
- What measures have been put in place to protect soil, air and water resources?
- How has water and energy use been reduced?
- How has the carbon footprint been reduced?
- What education activities are undertaken?
- Future plans

The winner will be presented with the Whitegrove Trophy and a cheque for £100 from the Staffordshire & Birmingham Agricultural Society. Entries must comply with the above conditions.
